REGULAR MEETING OF THE FIRE COMMISSIONERS – SEPTEMBER 16,2013

A presentation by Kevin O'Brien of Access Health Systems preceded the regular meeting. Access is an occupational heath provider. Their program is designed to provide physicals and other testing to clear firefighters for respiratory issues and determine classifications for each firefighter. The classifications are interior, exterior, support staff and social members.

Mr. O'Brien explained that they would review the medical history of the firefighter to determine the classification for a firefighter. They provide a hands on physical, EKG's, bloodwork, audio and visual exams. The Commissioners may choose to what extent they want firefighters tested for the different classifications.
